All Membership Agreements require a credit card on file. Payment will be processed on the first of each month. A \$15 fee will be added to any failed payment.

Gulf Gate Boxing rate schedule is as follows:

Classes: \$125/monthly · 24/7 Gym access: \$50/month · Private Training: \$65/ 45 min session

Member agrees to keep and obey all rules and regulations now in force or in the future prescribed by Gulf Gate Boxing, for the use of Gulf Gate Boxing training facility, premises, and equipment therein, and Gulf Gate Boxing reserves the right to revoke this membership for cause if the Member fails to keep and obey any of such rules regulations, or for reasons of nuisance or disturbance to other members or staff or fraud.

Member agrees that he will obey the following rules:

- Always considering other members' rights and privileges when training;
- Always pay membership on or before the first of the month;
- Always unloading all bars and machines when through using them and replacing all weight plates on their proper racks;
- Always replacing barbells and dumbbells on their proper racks at the end of each set;
- Always follow directions on the proper use of the training equipment and ask for directions when necessary;
- Never banging dumbbells together when doing flies or other exercises;
- Never dropping dumbbells or barbells on the floor;
- Shoes and shirts are required;
- Must have gloves and hand wraps for class, which MUST be purchased in advance;
- Always wear proper gym attire;
- Always accepting fullest responsibility for any damage done to equipment due to misuse of the equipment.

Without limiting Gulf Gate Boxing's ability to terminate this membership for cause, the Gym may terminate this membership for any reason at the end of any given month.

It is further agreed that all exercises including the use of weights, number of repetitions, and use of all machinery, equipment, and apparatus designed for exercising and the use of Gulf Gate Boxing's premises and facilities shall be at the Member's sole risk. Notwithstanding any consultation on exercise programs that may be provided by Gulf Gate Boxing employees or agents, it is hereby understood that the selection of exercise programs, methods, and types of equipment shall be the Member's entire responsibility and Gulf Gate Boxing shall not be liable to the Member or Member's family for any claims, demands, injuries, damages, or actions arising due to injury to the Members person or property arising out of or in connection with the use by Member of the services and facilities of Gulf Gate Boxing or the premises where the same is located. If Member brings any personal property onto the premises of Gulf Gate Boxing or in the parking area, Member takes such action at Member's sole risk. It is hereby understood that Gulf Gate Boxing is not responsible in any way for damage or loss of any personal property, including but not limited to, losses due to theft, damage, or car accident. Member hereby holds Gulf Gate Boxing, its successors assigns, owners, officers, directors, employees, and agents harmless from all claims which might be brought against them by Member, on Members behalf, by Members family, and Member's executors, administrators, and personal representatives for any such injuries or claims aforesaid and Member for himself and on behalf, by Member's family, and Member's executors, administrators, and personal representatives do hereby forever release and discharge Gulf Gate Boxing, its successors, assigns, owners, officers, directors, employees, and agents from all claims, demands, injuries, damages, actions, losses, and expenses.
